The European Union (EU), through its control of a little-known United Nations organization called the Codex Alimentarius Commission, is increasingly enabling multinational corporations – specifically those in the pharmaceutical, chemical and genetically-modified (GM) food industries - to control the health and lives of all six and a half billion people on planet earth. What is the Codex Alimentarius Commission?

The Codex Alimentarius Commission (Codex) is a United Nations organization that receives its funding from the World Health Organization (WHO) and the Food and Agriculture Organization (FAO) of the United Nations. Established in 1963, its main activities centre around the drafting of global standards for all food products, including food supplements. Working as a bloc, the EU's 27 member countries are increasingly using Codex to shape global food regulations to reflect EU law.

The key aim of the pharmaceutical, chemical and GM food industries

The pharmaceutical, chemical and GM food industries all have one important thing in common: they concentrate almost exclusively upon selling patented (i.e. new-to-nature) products. Non-patentable alternatives to the products produced by these industries are therefore seen as a threat because they put multi-billions of pounds of potential profits at risk.

As a result, the pharmaceutical, chemical and GM food industries want global food regulations to be harmonized in such a way as to ensure that non-patentable products such as natural health therapies (e.g. vitamin supple-

ments) and organic foods do not present an economic threat to the sales of synthetic chemical drugs, artificial food additives, pesticides and genetically-modified foods. The international vehicle through which they hope to achieve this aim is the Codex Alimentarius Commission. The main facilitator of their efforts is the EU. ■

ing health at the deepest and most important level in the human body – the cellular level. This level has been totally neglected by the pharmaceutical industry. Our research findings have been presented at dozens of scientific conferences around the world and published in numerous respected, peer-reviewed biomedical journals and Web sites.
